Booth Space & Tables

Market Date & Hours

Saturday, October 19, from 9 am - 4 pm. Entry is \$5; half price after 2 pm, 12 & under free. Show hours will be observed; no packing up until 4 pm. Vendor Setup is Friday, October 18, 9 am - 6 pm.

Vendors agree to observe the above listed show hours by having at least one person always present at Vendor's booth during show hours.

USE OF PREMISES: No nails, screws, bolts or fastenings are to be used on any part of the Exhibit & Entry Halls. No tape of any kind, besides painter's tape, is to be used. No permanent markings, pens, markers, paint, etc. is allowed.

DAMAGES AND INDEMNIFICATION: Vendor is responsible for all damages caused by Vendor. Vendor agrees to indemnify, defend, and hold The Vintage Rose, LLC harmless for all claims resulting from Vendor's negligence. The Vintage Rose, LLC is not liable for any damage or injury that may occur to Vendor, Vendor's employees or agents, or Vendor's goods or equipment unless the damage or injury is the result of The Vintage Rose, LLC's own negligence.

ATTORNEYS' FEES: If any party to this Contract institutes any legal cause of action—including arbitration—against another party arising out of or relating to this Contract, the prevailing party will be entitled to the costs incurred in conducting the cause of action, including reasonable attorneys' fees and expenses and court costs.
